### AMMC Approval of the prospectus relating to Bank Of Africa of subordinated perpetual bond issuance with loss absorption and coupon payment cancellation mechanism

The AMMC (Moroccan Capital Market Authority) informs the public that it has approved, on June 16, 2023, under the reference VI/EM/019/2023 a prospectus related to Bank Of Africa of subordinated perpetual bond issuance with loss absorption and coupon payment cancellation mechanism.

The prospectus approved by the AMMC is composed of:

- The reference document related to the financial year 2022, registered by the AMMC on June 16, 2023, under the reference EN/EM/009/2023;
- The offering document.

<b>Allocation method</b>	French auction, priority given to tranche A (fixed rate) then to tranche B (annually revisable rate)
