

The CDVM informs the public that it has approved, on the 5th of April 2013, a prospectus relating to the share buyback program launched by ITISSALAT AL-MAGHRIB in order to regulate its stock market.

The main characteristics of the program are as follows:

- Maximum number of shares to be held: 1 500 000 shares, (corresponding to 0,17% of the capital stock);
- Maximum purchasing price per share: 150 DH;
- Minimum selling price per share: 80 DH;
- Program's duration: 18 months starting the 7th of May 2013.

This program will be submitted for authorization to the ordinary general meeting, which will be held on April the 24th, 2013.

An excerpt of the prospectus will be published in a legal announcements newspaper.
