

The Moroccan Securities Ethics Council (CDVM) informs the public that it has approved, on August the 17th, 2012, the annual update of the prospectus related to the commercial paper issuance program launched by CAPEP, for fiscal year 2011.

The main characteristics of the program are as follows:

- Ceiling of issuance: 200.000.000 DH ;
- Unit nominal value: 100.000 DH ;
- Maturity : from 10 days to 12 months ;
- Interest rate: to be determined for each issuance, depending on the market conditions.
- Underwriter: BMCE Bank.

The information dossier approved by the CDVM must be:

- Handed in or addressed free of charge to any person requesting it, or that is approached in order to subscribe to an offer of the program,
