

The CDVM announces publicly that the Banque Populaire Régionale de Marrakech-Beni Mellal, represented by its chairman Mr Abdelkhalek Bendriss, declared on april 23rd, 2014, to have crossed the threshold of 5% of BCP's share capital upwards, following the acquisition of 1 302 610 shares in the block market at a price of 197,25 dh per share, on april 17th, 2014.

As a result of this transaction, the Banque Populaire Régionale de Marrakech-Beni Mellal holds 9 803 670 shares, representing 5,66% of BCP share capital.

Within twelve months following the threshold crossing, the Banque Populaire Régionale de Marrakech-Beni Mellal intends to continue buying the concerned security.
