

The CDVM announces publicly that Atlanta represented by its general director, M. Jalal Benchekroun, declared on July 25th, 2014 to have crossed directly the threshold of 5% of CIH Bank share capital upwards and indirectly, through controlled company Sanad, the threshold of 10% of CIH Bank share capital upwards, following the acquisition of 665 203 CIH Bank's shares in the block market at a price of 325 DH per share, on July 22nd 2014.

Following this threshold, Atlanta holds:

- Directly, 1 540 191 of CIH Bank shares, representing 5,78% of the company capital;
- Indirectly, through controlled company Sanad, 1 401 177 of CIH Bank Shares, representing 5,26% of the capital.

As a result, Atlanta holds overall (directly and indirectly) 11,05% of CIH Bank share capital.

Within twelve months following the threshold crossing, Atlanta intends to continue buying the concerned security.
